- 8. That businesses and other operations be carried out only at appropriate times;

- 10. The CUP shall, in all other respects, conform to the applicable regulations of the zoning district in which it is located, except as such regulations may, in each instance, be modified by the Governing Body.

### Statement of Request for Conditional Use Permit

I, Janice Pfund, Manager for Crab Trap LLC, am requesting a Conditional Use Permit for the property at 31 Spring Street, Irvington, VA, to be used to provide short term housing to visitors of Irvington, VA, and the surrounding areas. I will ensure that this use will not adversely affect the public health, safety, morals, and general welfare and will operate in compliance with the Chesapeake Bay Act.

This use of the property will not diminish or impair property values within the neighborhood as I will provide the upkeep and maintenance of the property to the highest standards. My experience in managing short and mid-term rentals over the last 10 years is extensive, and my properties have increased dramatically in value and in curb appeal. In addition, I am deeply concerned about the environmental impact and will ensure that strict guidelines for respectful use of trails, waterways and other natural areas are followed.

The Property is located on a wooded street with proper distance between homes, and there are appropriate trees and natural buffers to insure privacy and noise protection. Parking for three cars is available at the property and number of cars allowed will be restricted for renters. There are clear and defined lighted pathways provided on the property to reduced erosion of uncleared areas. There will be no additional signs posted on the property, and those already in use are in keeping with other properties in the area.

Quiet hours and other noise restrictions in keeping with local ordinances will be stated and strictly enforced by management. Check-in and check-out times will be restricted to normal business hours.

This use of property will, in all other respects, conform to the applicable regulations of the zoning district in which it is located, as determined by the Governing Body.

We are requesting a permit to use our 3 bedroom property as a short-term rental for up to six persons.
