The Treasurer reported a balance of \$4366.41 as of December 31, 1960.


The Mayor opened the floor for discussion of the proposed budget which was recorded in the minutes of the meeting held December 8, 1960.

Mr. Lokey made a motion which was seconded by Mr. Turlington that the agreement made between the Town of Irvington and the County of Lancaster on March 14, 1960 regarding motor vehicle license taxes be continued through the year 1961.

Mr. Foster reported on quotations for printing and indexing Town Ordinances. Price quoted was \$900.00 for 10 copies of 75 pages each. Upon motion by Mr. Lokey and seconded by Mr. Willing, this matter was tabled until the March Meeting.

RESOLUTION OF THE TOWN OF IRVINGTON

ADOPTED AT REGULAR MEETING HELD ON FEBRUARY 9, 1961

WHEREAS, The Commonwealth of Virginia, acting by and through the Department of Highways, has agreed to construct curb and gutter and improve the road bed of a portion of Virginia State Highway #634 beginning at its intersection with Virginia State Highway # 3 and extending into the area known as West Irvington, and

WHEREAS, the Highway Department has requested certain resolutions from the Town of Irvington in connection with said construction:

NOW, THEREFORE, be it resolved as follows:

- (1) That the Town of Irvington is aware of the fact and understands that no new sidewalks will be erected between Station 14# 68 and Station 34# 03 on the South side or left hand side of said Route 634 going towards West Irvington.
- (2) The Town of Irvington further understands and agrees that the existing sidewalks will not be replaced from Station 35# 13 to 41# 00; Station 43# 00 to 46# 75 on the left hand side going towards West Irvington; and Station 54# 35 to 60# 09 on the right hand side going towards West Irvington.
- (3) The Town of Irvington further requests that additional curb and gutter be erected and installed on both sides of Route # 634 from Station 35# 13 to Station 38# 50, this being a continuance of the

planned curb and gutter on said Route# 634, and the Town of Irvington agrees to pay one-half of the cost of this additional extension but not to exceed two thousand dollars (\$2000.00).

Upon motion by Mr. Turlington, seconded by Mr. Willing, and unanimously passed, Mr. Foster, Town Attorney, was authorized to contact the Michie City Publications Company and make the necessary arrangements for the printing of a new Town Code at a cost of nine hundred dollars (\$900.00) for seventy-five (75) pages, the Town to receive fifteen (15) copies, five (5) extra ones to be printed at a cost of \$4.50 each.

Mr. Willing made a motion which was seconded by Mr. Foster that the Highway Department be requested to drain a stagnant pond on the property of Mr. T. C. Treakle.

Upon motion by Mr. Lokey and seconded by Mr. Foster, it was decided to request the Department of Highways to take over and maintain an additional two-tenths of a mile of road leading from Route No. 634 to the homes of D. M. Headley, Newbill Broadus and others.

Upon motion by Mr. Lokey and seconded by Mr. Turlington, the following Resolution was unanimously adopted:




WHEREAS, The Town of Irvington has previously passed a resolution guaranteeing the necessary right of way for said improvements pursuant to plans previously submitted and,

A street beginning at a point on Route 634 0.01 Mile Northwest of Intersection Route 715 and Route 634 and running in a Southwesterly direction a distance of 975 feet or 0.18 Mile, Whereupon it appearing to the Council that written consents conveying to the Town the necessary rights-of-way for said addition, forty (40) feet wide at all points, together with such additional widths as may be necessary for the extension and maintenance of road slopes and for ditches and all necessary drainage facilities, said right of way to be free of all encroachments, has been duly recorded in Deed Book #121, Page #447 at the Court House on April 29, 1960.

ORDINANCE ENACTED BY THE TOWN OF IRVINGTON AT A
REGULAR MEETING OF THE TOWN COUNCIL HELD ON THURSDAY,
APRIL 13, 1961

Be it ordained by the Council of the Town of Irvington that there shall be levied for the calendar year 1961 and each year thereafter in accordance with the laws of the Commonwealth of Virginia as set forth in the Code of Virginia, Section 58-476.2, a tax at the rate of \$.80 on each \$100.00 of the taxable value of each share of stock, or a tax equivalent to 80% of the state rate of taxation, which ever is greater, on the shares of stock in banks as defined in Section 58-465 of Michie's Code of Virginia of 1960, and amendments thereto, located in the Town of Irvington, and every bank in the town shall deliver to the Clerk of the Council on or before the 1st day of February of each year a copy of the report which it is required to file by Chapter 10, Title 58 of the aforesaid code. The tax as hereby levied shall be paid and collected in accordance with the laws of the Commonwealth of Virginia.

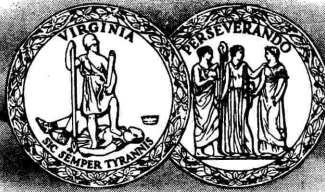
