Mayor Haynie called the meeting to order and requested the clerk to read the minutes of the meeting held December 14, 1961. These minutes were approved as read.

Mr. Jones reported that his attempt to contact Mr. Arnold had been unsuccessful.

Mr. Jones also reported that Mr. Fallin Bryant had agreed to notify Mr. Jones if and when he could move trees and shubbery.

Mr. Foster reported that Mr. Fidler had agreed to introduce a bill to reduce the number of members of the Irvington Town Council from seven to six.

The Town Treasurer reported a balance of \$5,459.19 as of December 30, 1961.

Upon motion by Mr. Donahue and seconded by Mr. Foster the budget for the period beginning January 1, 1962 and ending December 31, 1962 was adopted as proposed in the meeting held December 14, 1961.

Mr. Lokey offered to accompany Mr. J. J. Mercer to Callao, Va. to make a survey of the Mercury Vapor street lights in that community.

Mr. Foster reported that the total cost of the codification, indexing and printing of the general ordinances of the Town of Irvington will be \$1,824.79.

Upon motion by Mr. Lokey and seconded by Mr. Donahue the following ordinance was unanimously adopted after its first reading:

ADOPTION OF CODE

An ordinance of the Town of Irvington, Virginia, adopting a revision and codification of the ordinances of the Town of Irvington, Virginia, entitled "The Code of the Town of Irvington, Virginia", providing for the repeal of certain ordinances not included therein, with certain exceptions, and for other purposes hereinafter set out.

Be it ordained by the council of the Town of Irvington;

(Continued)

Section 1. There is hereby adopted by the town council of the Town of Irvington, Virginia, that certain Code entitled "The Code of the Town of Irvington, Virginia", containing certain ordinances of a general and permanent nature as revised, compiled, consolidated and codified in the following chapters, namely Chapters 1 to 10, both inclusive.

Section 2. The provisions of such code shall be in force on and after March 1, 1962, and all ordinances of a general and permanent nature enacted on or prior to October 6, 1961, and not contained in such Code are hereby repealed from and after March 1, 1962, except as hereinafter provided.

Section 3. The repeal provided for in the preceding section of this ordinance shall not affect any offense or act committed or done or any penalty or forfeiture incurred or any contract or right established or accruing before March 1, 1962; nor shall it affect any prosecution, suit, or proceeding pending or any judgment rendered on or prior to the said March 1, 1962; nor shall such repeal affect any ordinance or resolution promising or guaranteeing the payment of money by or for the Town or authorizing the issue of any bonds of the Town or any evidence of indebtedness or any contract or obligation assumed by the Town; nor shall such repeal affect the administrative ordinances or resolutions of the council not in conflict or inconsistent with the provisions of such Code; nor shall it affect any right or franchise conferred by ordinance or resolution of the Town on any person or corporation; nor shall it affect any ordinance adopted for purposes which have been consummated or any ordinance which is temporary, although general in effect, or special, although permanent in effect; nor shall it affect any of the following ordinances or any amendment thereto:


- (a) Any appropriation ordinance;
- (b) Any ordinance levying or imposing taxes;
- (c) Any ordinance providing for any public improvement;
- (d) Any ordinance making any assessment;
- (e) Any ordinance opening, relocating, closing, altering or naming any streets or alleys;
- (f) Any ordinance relative to salaries, compensation or bonds of Town employees and officials or members of Town boards or commissions.

Section 4. Neither the repeal provided for in section 2 of this ordinance nor the provisions of such Code shall be construed to affect any ordinance passed after October 6, 1961.

Section 5. Copies of this ordinance and of such code shall be posted in at least two public places in the Town immediately after passage and shall remain so posted for a period of thirty days from and after passage.

There being no further business the meeting adjourned.

Mrs. Charlotte Turlington requested that the Town install and maintain at least two street lights on road leading to the homes of Thomas Turlington and Mrs. James Wilder. No action was taken at this meeting.

Mayor Haynie requested the Clerk to read the minutes of the meeting held February 8, 1962. Minutes approved as read.

The lighting committee was authorized to meet with representatives of Virginia Electric and Power Company and make plans for the installation of Mercury lights.

The Treasurer reported a balance of \$3,719.12 as of February 28, 1962.

Mr. Foster made a motion which was seconded by Mr. Willing that a committee be appointed to inspect road signs and secure some person to complete these signs and select an appropriate place to erect them. Committee appointed: Anderson L. Gaskins, W. J. Haynie. Motion carried.



Mr. Willing made a motion which was seconded by Mr. Donahue that this Special Meeting be combined with the Regular August meeting. Motion carried.

Mayor Haynie instructed the clerk to read the minutes of the regular meeting held July 12, 1962. These minutes were approved as read.

Mr. Lokey made a motion which was seconded by Mr. Willing granting the Clyde Royals Construction Company to use the Community Property for storage of gravel used for top dressing during the road construction. Motion carried.

Treasurer reported a balance of \$4,771.93 as of July 31, 1962.

Upon motion by Mr. Foster and seconded by Mr. Willing it was agreed to remove shubbery from the front of the Library Building.

Dixon L. Foster, the town attorney, next gave a report on the progress being made on the road in West Irvington. He stated that he had worked out an agreement whereby Aubrey Lowery would exchange with Frank Henderson, Robert Dew and Kenneth Higgins a piece of land adjacent to the community center property in order to construct a drainage ditch and also that Frank Henderson, Robert Dew and Kenneth Higgins were willing to give to the state or town a right-of-way over the 25 foot road leading to the property of Thomas J. Willing estate, upon condition that the town agree to take over 1/8 of a mile of the roads on the property of Frank Henderson, Robert Dew and Kenneth Higgins per year until all of the roads on their property are included in the town highway system. He, also, stated it was necessary for the town to pay a part of the costs of putting a culvert across the property of Elizabeth Lee Lokey in connection with the drainage ditch. Upon motion duly made, seconded and unanimously passed, the following resolution was adopted:

"RESOLVED: That the Town of Irvington request the Commonwealth of Virginia to include in its highway system within the Town limits one-eighth (1/8) of a mile per year of the roads presently constructed and located on the property of Franklin D. Henderson, Robert G. Dew and Kenneth R. Higgins.

That the Town of Irvington participate in the construction of a drainage ditch across the property of Elizabeth Lee Lokey to the extent of purchasing culverts necessary to completely cross the Lokey property, provided the Commonwealth of Virginia constructs the ditch and covers up the culverts after they have been put in place."

Mr. Lokey presented a bill for \$336.16 from the Highway Department for material used for construction of drainage ditches. Upon motion by Mr. Turlington and seconded by Mr. Donahue the Treasurer was authorized to pay the above amount.

Mr. Donahue requested that some action be taken regarding the maintenance of road leading to the home of Mr. Donahue and others.

Mr. Lokey made a motion which was seconded by Mr. Donahue that the town attorney be authorized to write to the District Engineer and request necessary repairs. Motion carried.

Mayor appointed the following Members for the 1963 Budget Committee: A. G. Lokey, Anderson L. Gaskins and M. J. Donahue, Jr.
