Be it resolved by the Council of the Town of Irvington, Virginia, on this day of October, 1969, As follows:

Section 1. A Town Planning Commission is hereby created for the Town of Irvington, Virginia, in accordance with the provisions of Chapter 11, Title 15.1, Article 3, Section 15.1-437, Code of Virginia. Said Commission shall consist of five (5) members, one of whom shall be a member of the Town Council, and one of which shall be the Town Clerk and the remaining three (3), hereinafter referred to as appointed members, shall be qualified voters of Irvington. All of the members shall be appointed by the Council of Irvington. The term of the councilmanic member shall in all cases correspond to his tenure of office. Of the other members first appointed, one (1) shall be appointed forrasterm of bie (1) year, one (1) shall be appointed for a term of two (2) years, one (1) shall be appointed of a term of three (3) years, from and after the effective date of this resolution, provided that the term of the clerk and the council member shall conform to Sec. 15.1-437 of the Code of Virginia, 1950 as amended. Their successors shall be appointed for terms of four (4) years. Any vacancy in membership shall be filled by appointment by the Council and such appointment, in case of an appointed member, shall be for the unexpired term. Any appointed member may be removed by the Council for inefficiency, neglect of duty or malfeasance in office, provided that such removal may be made only after a public hearing at which said member is given an opportunity to appear and be heard on the charge against him.

Section 2. The Town Planning Commission shall have the functions, powers, and duties which are prescribed by law.

Section 3. As soon as practicable after the appointment of the members thereof, the Town Planning Commission shall adopt bylaws and establish a program of work after consulation with the Council. This program of work shall outline the activities in which the commission expects to engage in Page 3 - October 9, 1969

(a) assembling such data regarding the Town of Irvington and adjacent territory as said commission may deem to be necessary in exercising its functions, powers, and duties; (b) analyzing such data and making such studies as may be necessary in the preparation of a comprehensive plan for Irvington; (c) preparing the comprehensive plan as a general guide for the development of the Town, and as a basis for the preparation of zoning and other regulations; and (d) recommending to the Council appropriate procedures for effectuating the comprehensive plan.

Section 4. This resolution shall take effect and shall be in force and effect from and after 13 November 1969.

"That the Board of Supervisors of Lancaster County are requested to authorize the construction of the curbs and gutters, which were contemplated in the aforesaid project on said Route No. 634 from a point where the present curbs and gutters end to the intersection of Route No. 633, a distance of approximately .4 of a mile, all rights of way being previously obtained on Project 1351-06, and there being no reason the said project could not be commenced without further condemnation proceedings or delay."

Mayor Luckham reported that in an interview with Mr. McBroom regarding curb and gutter on West Irvington Road from The Tides Inn entrance to Boat Basin Road, and also a public landing that Mr. McBroom suggested that the Town work through the Lancaster County Board of Supervisors in both cases.

Upon motion by Mr. Paulette and seconded by Mr. Gunther the Treasurer was authorized to pay to the Treasurer of Lancaster County the sum of \$1,800.00 from the proceeds of the sale of automobile license plates.

Upon motion by Mr. Paulette and seconded by Mr. Gaskins it was agreed to purchase a larger fuel tank for the Library Building. Upon motion by Mr. Gaskins and Mrs. Fleet it was agreed to request that the Virginia Department of Highways: install a stop sign or a yield sign at the following locations: On Route No. 746 at its intersection with Route No. 636, on Route No. 636 at its intersection with Route No. 635 and on Route No. 776 at its intersection with Route No. 635.

The following subjects were brought to the attention of the members of Town Council for discussion:

2. Henry Whay, Joseph Gunther and Mrs. Fleet as a committee to make recommendations for Christmas decorations in town.

- 4. Send letters to owners of property who have abandoned wells.
- 5. Additional card file for Library.
- 6. Check street lighting in center of town.
- 7. Horseback riding on sidewalks.
- 8. Trailer ordinance.
- 9. Abandoment of Ferry Dock Road.
