
In this special meeting the members of Council discussed appointments to the Irvington Planning Commission.

Upon motion by Mr. Paulette and seconded by Mr. Reynolds, the proposed budget was accepted as proposed after its first reading.


Members of Council authorized Mayor Luckham to write Mr. R. S. Reeves a letter of appreciation for his work in erecting the Christmas decorations.

Mayor Luckham discussed the sewage problem of the King Carter Tavern and by unanimous decision Mayor Luckham was authorized to offer the following suggestions and comments:

Dear Mrs. Savage:

The Irvington Town Council, in a special meeting on 16 September 1970, discussed your sewage problems at length and it was the unanimous decision to offer the following suggestions and comments.

The Council recommends that you have installed on your property to the fullest extent and capability of your property drain tile as may be prescribed by the health department. This should include the moving and transplanting of necessary shrubs, bushes and other unnecessary obstructions. It is also our recommendation, provided the local health officer concurs, that the drainage ditch which runs across the back of your property along Chesapeake Drive and crosses Tidewater drive be deepened, as engineered by the Highway Department. A drawing of this project was turned over to the county health officer. The Council will assist you in this project by contacting the State Highway Department.

If this amount of drain tile does not handle the sewage drainage in the months to come and a determination is made that it is insufficient, this Council will permit additional tile, up to one half your estimated needs, to be placed on the Community Property at a location which this Council will direct. These months will permit this Council to determine its land use to the best benefit.

If in the future you wish to utilize the Community Property for your drainage needs, this Council will permit this use at the pleasure of the Council and will reserve the right to cancel this authorization at its discretion and due notice to you. This council will require the full utilization of your property to reduce the amount of Community Property which may be needed. This Council will also require a water shut-off valve be placed in the head of the line on the Community Property which will permit the Town of Irvington to control any leakage to the top of the ground.

We of the Council are sympathetic with your problem and we hope you can appreciate the need for us to protect the public interest as regards the best use of the Community Property so as not to jeopardize its best use.





Mrs. Fleet reported some recreational equipment acquired such as picnic table, boat for sand pile, basketball goals, swings and barbecue stand.

Attorney Simmons suggested that the code could be simplified so that it would apply to the Town of Irvington and rely on State Laws for others that may occur. Mrs. Simmons will check into this matter and report back to council.

Mrs. Savage of the King Carter Tavern appeared before council and requested them to assist her in solving her drainage problem.

Mayor Luckham stated that a Landacape Engineer has approached him seeking permission to plan the community grounds.

Mayor Luckham called the meeting to order and the Clerk read the minutes of the regular meeting held April 9, 1970. These minutes were approved as read.

The Treasurer's report was approved as read.

Mr. Donahue made a motion which was seconded by Mr. Gaskins that the Town of Irvington join the Virginia Municipal League for another year.

Mayor Luckham stated that he would write a letter of appreciation to Mr. Ed. Painter for making the Library sign.

Upon motion by Mr. Donahue and seconded by Mrs. Fleet the following resolution was adopted:

BE IT RESOLVED:

The Irvington Town Council wishes to give thanks to the Irvington Garden Club for their efforts in making our town a better place to live through their making us aware of the beauty of flowers and shrubs and further the Irvington Town Council commends the Irvington Garden Club for the fine job they have done during the Spring Cleanup Campaign in cleaning up the roadways and providing trash pickup services to the entire community.

Mr. Gaskins reported that Theodore Fisher has promised to work on the Recreation Grounds.

Mrs. Fleet reported that the "Happiness Is" organization has purchased basket ball baskets and will install them on the recreation grounds.

Mr. Gunther reported that he has received two quotes on material for the new building, however, he has not received any bids for the construction. Mr. Gunther will continue to seek bids for construction.

Mrs. Guthridge reported on the activities of the Library, and also requested permission to open the Library from 9:30 a.m. to 11:30 a.m. on Wednesdays and from 9:30 a.m. to 11:30 a.m. on Fridays.

Mr. Gaskins made a motion which was seconded by Mr. Donahue to grant permission to keep the Library open the additional hours as requested and also to increase the salary of the Librarian to \$50.00 per month provided she works additional hours. Permission was also granted to hold a birthday celebration for the Library on June 7, 1970 and Town Council will defray the cost of such celebration.

The Chamber of Commerce was represented by a committee consisting of Mr. Harper, Mrs. Hall and Mr. Barrack. Mr. Harper stated that they represented the citizens of West Irvington and urged the completion of the sidewalks and curb and gutter projects. Mrs. Hall also requested that this matter may be followed through. Mayor Luckham read the files regarding the efforts which have been made in attempting to get some commitment from the Highway Department.

The Chamber of Commerce in response to naming the streets sent in a list of suggested names.

Mr. Donahue stated that he would like to express the appreciation of the council for the time and effort spent by the Chamber of Commerce and others who have contributed so much to this project.

Members of Council agreed to meet on May 28 to make further study of naming the streets.

Upon motion by Mr. Gaskins and seconded by Mrs. Fleet it was agreed to clean up Recreation Grounds, clean and remove dugouts, replace back stop and repair bleachers and level and fill holes on the grounds to make suitable for recreation.

Mayor Luckham called the meeting to order and the clerk read the minutes of the regular meeting held January 8, 1970. These minutes were approved as read.

The treasurer's report was approved as read.

Mayor Luckham reported that he has been advised that the board of supervisors is now considering a tract of land to establish a dump in the lower end of Lancaster County.

Upon motion by Mr. Paulette and seconded by Mr. Gaskins it was agreed to increase the salary of Sergeant Shelton by the sum of \$25.00 per month. This increase to be effective January 1, 1970.

Mr. Donahue made a motion which was seconded by Mr. Paulette whereby Mrs. Frank Guthridge was appointed as chairman of the Irvington Library Board, and also Mrs. Jack Harper was appointed to fill a vacancy as a member of the same board.

Mayor Luckham reported that Mr. Bradley of the Virginia Electric & Power Company has given verbal permission to attach brackets on utility poles for holding flags.

Upon motion by Mr. Donahue and seconded by Mr. Gaskins the members of the council voted to purchase fifty U. S. Flags to be flown on holidays and other days.

The following persons were agreed upon to be responsible for erecting and removing flags and for safe keeping while not in use: Mrs. Suzanne Fleet, Chairman; W. T. Toleman, Frank Guthridge, Dick Painter, the Rev. Dick Newlon, Frederick Messick and Mr. Jerry Hammell.

The Mayor reported that Mr. Rhoades, Resident Engineer, has advised that he will check into the programs on the curb and gutters project for the West Irvington Road.

Mayor Luckham reported that he had written to the Department of Highways requesting permission to have snow cleaned from the secondary roads within the corporate limits of Irvington. Mr. Donahue suggested that contractors be contacted to ascertain the cost of such snow removal.

February 12, 1970

Upon motion by Mr. Donahue and seconded by Mrs. Fleet members of council voted to donate the sum of \$50.00 to the Kilmarnock Volunteer Fire Department and the sum of \$100.00 to the White Stone Volunteer Fire Department.


Mayor Luckham proclaimed the period from April 6, 1970 through April 18, 1970 as clean up week in Irvington, Virginia.

The Treasurer's report was approved as read.

Mayor Luckham reported that he has been advised by the Division of Planning and Community Affairs of the State that he will be notified as soon as they have someone available to meet with the Irvington Planning Commission.

Mayor Luckham reported that he has received quotations for American Flags for the town, however there appears to be some problems such as a place to store flags and someone responsible for the flags. One suggestion: A general chairman with a captain for about each ten property owners who will be responsible for the flags in a certain area. It was agreed to table the purchase of flags until Virginia Electric and Power Company can be contacted for permission to attach flags to utility poles.
