News Release

IRVINGTON REBUTS YACHT CLUB ALLEGATIONS

<u>The Irvington Town Council at its egular April meeting discussed at</u> length the several recent news articles and letters to the editors referring to opposition by the Town Council of Waterman's Day on Carters Creek.

Since none of the quotations or alleged statements appearing in the news articles were considered by the Council to be representative of the statements or actions of the Council or any of its members, the Council passed the following resolution, which it hopes the public will take notice.

WHEREAS, recent local news articles have stated that "the decision to cancel --- sponsorship (of Waterman's Day on Carters Creek) this year was due to local opposition, strongly voiced by a few individuals," and

WHEREAS, statements in recent news articles have referred to complaints by Irvington Town Council members "about the thousands of boats --- which choked the creek (on Waterman's Day)," and

WHEREAS, a statewide newspaper contained a news article which stated that there had been concern expressed about an Irvington Town Councilman's statement at a U. S. Army Corp of Engineers public hearing, making reference to "overcrowding (of Carters Creek) such as that during the annual Waterman's Day Celebration," and

WHEREAS, the Town Council has financially supported Waterman's Day on Carters Creek in past years and is unaware of any Councilman's alleged complaints about Waterman's Day as have been referred to in the newspapers, and

WHEREAS, the official transcript of the Corp of Engineers public hearing referred to in news articles did not contain the direct statement attributed to a Town Councilman, nor did the transcript contain a similar statement. In fact the transcript clearly shows that the context of the Councilman's remarks about Waterman's Day were just the opposite of the comments quoted in the news releases.

BE IT THEREFORE RESOLVED

THAT, the Town Council of Irvington deplores that any of its actions or that of its individual members relative to Waterman's Day may have been misinterpreted, and

THAT, the Town Council of Irvington reaffirms its support of Waterman's Day on Carters Creek and the welfare and objectives of the local waterman and the Virginia Waterman's Association.

THAT, the Town Council of Irvington strongly urges Gloucester Cable Vision to stand behind the proposed level of service to all residences within the town limits of Irvington, as proposed on August 13, 1981.
