Attorney Kilduff said one way that could be considered would be to own the water system and lease it back to Sydnor, also, he would look into a payback for the \$20,000 from the town.

NEW BUSINESS

Joe McCarty discussed having a public joint meeting with the planning commission and town council on proposed amendments. Notice for such meeting would have to be published in the Rappahannock Record for two weeks. The notice would be in the November 21st and 29th issues as of this council meeting. No meeting place was decided upon. Motion made by Ray Reynolds, seconded by Bob Barrack to hold the meeting at 7:p.m. Thursday December 6, 1984, unanimously approved.

A letter from the town is to be sent to Continental Telephone Co. asking them to correct two damaged poles in the town.

A letter of appreciation from the White Stone Fire Dept. was read thanking the town for the contribution made to them.

After an introduction from Mr. Joseph McCarty, Mr. Kilduff told the members about his position as legal advisor for Northumberland. Most of his legal work has involved zoning ordinances.

Mr. McCarty commented that the desire of the council is to have good government, to be consistent, and because of the small town concept we did not want to over develop.

Mr. Sanders advised Mr. Kilduff of the zoning ordinances due to be acted upon very soon and would like Mr. Kilduff to read and become familiar with new changes. Mr. Sanders asked Mr. Kilduff to be sure the town complies with ordinance as to public hearings and that the mayor and council members are advised of proper procedure for having a public meeting for zoning changes.

Council members expressed concern about what the council is allowed to do about new revenue for the council to meet the needs of the town budget.

Mr. McCarty made a motion to hire Mr. Kilduff for \$100.00 retainer fee annually, with the understanding that Mr. Kilduff will charge \$50.00 per hour for service adjustment when he is in a case situation. He will attend several regular meetings to familiarize himself with Irvington Business.

Motion was made by Joe McCarty to rescind moratorium on pool construction, seconded by Bob Barrack, motion carried. Council decided to send letters to pool owners concerning the appropriate pool filling times which would be midnight to 6 AM. Motion made by Joe McCarty seconded by Bob Barrack, unanimously approved.

Mrs. Bill Smiths botique application was discussed by Calvin Barrack with council. Council ruled in favor of Mrs. Smith. Also, Broadus application for storage building was discussed by Calvin Barrack with council. ~~Council ruled in favor of Broadus.~~

3. The Westminster Canterbury project lies outside the jurisdictional bounds of Irvington, Va. yet Carters Creek and Irvington suffer the consequences of the runoff and sedimentation because they lie down stream from the project.

Mr. McCarty suggested that the letter be signed by the Mayor as designated by the Irvington Town Council. Buddy Gunther was instructed to make it clear to the Board of Supervisors that he was presenting the letter for the Irvington Town Council and if he had anything additional to say it would be on his own.
