Irvington Town Council Special Meeting December 16, 2004

A special meeting of the Irvington Town Council was held at 12:30 P.M., at the Irvington Town Office for the purpose of having the required second reading of the proposed amendment to the Town Council that would allow non-residential church structures or other non-residential places of worship to have a minimum side or rear setback of ten (10) feet rather than the current required thirty-five (35) feet when adjacent to a residential district. This would apply to churches located in residential and B-1 Business districts.

The Mayor called the meeting to order. Mr. Terry read the proposed amendment to the Ordinance. Norman Mosher made a motion to approve the amendment and Richard Pittman seconded the motion. (Ransone arrived.) Vote- Yea: Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

Mr. Mosher questioned the B-2 Business District's not being included as an affected district. Mr. Terry said that it was so small that he did not include that district.

BZA's Variance Granted to "The Local"

The Mayor explained that Mr. Doug Reed, on behalf of his business requested a variance to the Ordinance to keep his sign that is 50-55 square feet attached to the building. The Ordinance requires that attached-to-building signs be no larger than 36 square feet. Mr. Reed applied for an after-the-fact variance as he had not obtained a zoning permit before placing the sign on the building. The BZA granted the variance. In view of the recent Virginia Supreme Court decision in the Cochran vs. Fairfax County Board of Zoning Appeals and concern for the precedent that would be set, and that an appointed body by the Town Council had broken the law in granting the variance, the Mayor said there are two options for the Town Council:

- 1.) Appeal to the State Circuit Court to have the variance rescinded. (It would be The Town Council, Town of Irvington vs. Board of Zoning Appeals, Town of Irvington.)
- 2.) Do nothing

Mr. Terry will not represent the Town against the BZA. Mr. Jimmy Cornwell, the County Attorney, has stated that he will take the case and charge \$200.00 per hour. He estimates that it will take no more than 15 hours, and more likely closer to 10 hours.

In discussing the precedent that the granting of this variance would set, Mr. Terry explained that each variance is unique and should stand alone and not be considered a precedent. He said that if the owner has a problem with the sign ordinance, then he or she should apply for an amendment to the Ordinance.

Mr. Fitzpatrick will talk with Mr. Reed and try to get him to make the sign smaller and in compliance with the Ordinance. The Town Council will have to file a petition to the Circuit Court to rescind the variance to "protect the integrity of the Ordinance."

It was decided that the Town Council will discuss the pending and potential litigation on Monday, January 10, 2005, at 7:30 P.M., at a called special meeting. A notice of the closed meeting will be published in the newspaper and one will be posted on the door.

Mr. Terry recommended that in the future, that a brochure be prepared stating the ordinances that affect businesses coming into Irvington,

Article 6-Business District B-1 - Church a permitted use with a C.U.P.

Sec. 6-3-3 For non-residential church structures or other non-residential places of worship, the minimum side yard or rear yard adjoining or adjacent to a residential district shall be located ten (10) feet or more as measured from the closest point of a structure to the nearest property line or to the edge of any private right of way. Such church structures do not include church schools or day care centers, other than Sunday schools. At such time as the structure is no longer used as a church or a place of worship then a conditional use permit will be required for any subsequent use.

Article 5-Residential District R-1 - Church a permitted use with Zoning Permit

Sec. 5-5-3 For non-residential church structures or other non-residential places of worship, the minimum side yard or rear yard adjoining or adjacent to a residential district shall be located ten (10) feet or more as measured from the closest point of a structure to the nearest property line or to the edge of any private right of way. Such church structures do not include church schools or day care centers, other than Sunday schools. At such time as the structure is no longer used as a church or a place of worship then a conditional use permit will be required for any subsequent use.

If the church building use should thereafter change then a restriction CUP would be needed for any other use i.e. Day Care Center or Church School. Sunday School would be included as part of the a church activity. Normal Church activities do not disturb the residential neighborhood. Norman Mosher made a motion to come out of public hearing. Richard Pittman seconded the motion. Vote – Yea: Luckham, Mosher, Pollard, Pittman, and Ransone. Nay: 0. In discussion, Mr. Mosher's suggested adding "non-residential" to the wording of places of worship and the Council members agreed.

Mr. Fitzpatrick stated by the Irvington Code, that there must be a second reading of the amendment no closer to this meeting than one week. The council decided to hold a special meeting on Thursday, December 16, 2004, at 12:30 P.M. Norman Mosher made a motion that the proposed

Mr. Fitzpatrick said that Best Management Practices must be observed and a site plan must be submitted. Presentation:

Mr. William Pennell, County Administrator, explained that in the past, transportation issues have prevented economic development in the Northern Neck, but now access to broadband services is impacting economic development. Efforts are being made to form the Northern Neck Communications Network Authority to provide broadband service to the area at a monthly fee under \$35.00. It would be done in partnership with the internet service providers and sharing tower space on probably 5 towers to transmit information. Support from the Town Councils in the County is needed. Mr. Alex Equiguren, a graphics designer on the Northern Neck Planning District Commission staff, made a slide presentation.

Public Hearing:

<u>CUP</u>; <u>SWIMMING POOL – Vineyard Development</u>: Bill Evans made a motion to go into a public hearing and Norman Mosher seconded the motion. Mr. Fitzpatrick reported that the fees have been paid, notices given, favorable responses have been received, and the Planning Commission unanimously approved the application. The Mayor called the meeting to order, led the group in prayer, welcomed Richard Pittman to the Council, and welcomed visitors.

Public Hearing:

SUBDIVISION: Mr. & Mrs. Jeffrey Bishop - 47 Mad Calf Lane: Kathleen Pollard made a motion to go into a public hearing. William Evans seconded the motion. Vote - Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0. Mr. and Mrs. Bishop are applying to subdivide their property into two parcels, each 1.01 acres. Mr. Fitzpatrick stated that the fees had been paid and notices had been given. He said that the Planning Commission had forwarded the application to the Council without recommendation as there were only three Commission members present at the meeting and two had voted to approve the subdivision and one had abstained. The subdivision if approved by the Council will be contingent on the Health Department's approval of the sites for septic systems. (Ralph Ransone arrived.) Gary Grabbe has received the final plat.

Mr. Bugg, representing Mr. Jerry Levey, who lives next door to the proposed parcel created by the subdivision, stated that Mr. Levey opposes the subdivision because he does not want a house next to him and gave the following reasons:

- 1.) Mr. Levey thinks that the lot being created cannot be built upon without a zoning variance. The lot is required to be 100 wide at the setback line. The widest point of the lot is 98.65 feet and the lot scales to 93.75 feet at setback. If the house were rotated, then 110 feet would be needed to accommodate setbacks-75 feet from the middle of the road and 35 feet for the rear setback. There is no need to subdivide unless one is going to put a house on the lot as anything else would not require subdivision.
- 2.) If a proposed building does not meet the zoning requirements, then the request goes to the BZA. Mr. Bugg stated that he thinks that the future owner will want to put a house on the lot.
- 3.) According to the survey, each lot would be 1.01 acre "more or less". Mr. Bugg said that the Town should require a survey which does not say more or less.
- 4.) The Subdivision Ordinance states that a subdivided lot in order to achieve the required square footage (one acre) cannot include a perculiarly shaped area that otherwise would be unusable for normal purposes. He considers that the subdivided lot does include a perculiarly shaped elongation, which has been noted that this could be used for the septic system. He stated that part of the lot dropped off (to a lower elevation).

In response to Mr. Evans' question about the recommendation of the Town Attorney, the response was that Mr. Terry had represented both parties in the past. Mr. Evans later said that he thought the Council needed legal counsel.

Mr. Bishop stated that the process is black and white. It either meets the requirements or it does not. He stated that Mr. Bugg's suppositions are not applicable as the issue of building is only relevant when seeking building permits. Their request is not to change rules – just to meet ones in effect. He read a letter in which he stated that their purpose of subdividing is for estate planning and said Mr. Levey may object because his house is very near the Western property line of the new lot that now appears to belong to Mr. Levey.

Mr. Levey stated the widths of the lots at various points: 73' on the water, 88' at the widest point, and 80' at the proposed 25 foot right of way. He thinks that subdivision would devalue the property. He said that he has been told that they were going to build formal gardens. He said they do not need to sub divide to do that. He said that he would object to any future variances.

Mr. Fitzpatrick said that the subdivision ordinance sets forth the parameters to subdivide. The survey is dated July 26, 2004, and in form to record in the County's office and would be proof positive that the acreage is sufficient to subdivide. The setback requirements are from the zoning ordinance and not from the subdivision ordinance. The bottom line is that the survey meets the subdivision requirements. Other arguments are superfluous to this arguement. Garry Luckham made a motion to come out of the public hearing. Richard Pittman seconded the motion. Vote – Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

Discussion: Mr. Evans said that the request has met the conditions. Mr. Luckham said that he did not see how they could deny the request. Mrs. Pollard said that they have previously approved perculiarly shaped lots. Mr. Mosher said that they could not decide the future, only what is before them. Kathleen Pollard made a motion to approve the subdivision contingent on the Health Department's approval of septic sites. Garry Luckham seconded the motion. Vote - Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay. 0.



Public Hearing:

T-21 Grant Application by Steamboat Era Museum: Kathleen Pollard made a motion to go into a public hearing. Ralph Ransone seconded the motion. Vote - Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0. Mr. McAfee, president of the Steamboat Era Museum, welcomed the Council. He stated that the Museum is applying for a grant of \$200,000 to renovate the Pilot House. The grant is a federal grant that is administered by VDOT and it is necessary that a municipality be the recipient of the grant. The Museum would be responsible for meeting the required 20% matching and would be responsible for the expenditures for which the grant would reimburse 80% of the amount of the grant. Don McCann will write the grant application, that must be submitted by November 1st. The Museum plans to replicate the Pilot House and have the work completed by 2005-2006. Mr. Mattingly stated that there are only two steamboats restored in the country and the Pilot House of the Potomac Steamboat represents an important part of a third steamboat. Mrs. McClintock, whose grandfather was one of the captains of the Potomac, gave a brief history of the steamboat. Norman Mosher made a motion to come out of public hearing and Garry Luckham seconded the motion. Vote - Yea: Evans, Luckhman, Mosher, Pittman, Pollard, and Ransone, Nay: 0. Mrs. Pollard asked if they were going to work on the Pilot House before getting the grant. Mr. Doug Power said that they have placed supports under it to stabilize it. They will start with a fresh base and plan to start in the Spring. The Museum would like to place it in the parking lot of the Museum and connect it to the Museum. Norman Mosher made a motion to support the Museum in its application for a T-21 grant to restore the Pilot House. Ralph Ransone seconded the motion. Vote -Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

Dear Mayor Fleet:

As you may know, the Lancaster County Department of Emergency Services, with the approval of the Lancaster County Board of Supervisors has undertaken several projects to improve Lancaster County's ability to respond to natural and man-made disasters in the future. Some of these projects are:

- Arranged for a generator to be installed at WKWI radio so local information will be available to Lancaster County citizens.
- Installation of a new generator/transfer switch at the Sheriff's Office to ensure that all operational and environmental systems are functional in a power failure.
- Installed emergency radio equipment and generators in White Stone, Kilmarnock and Litwalton to provide repeaters for sheriff/fire/rescue radio improvement.
- Established a new Emergency Operations Center at the Kilmarnock Rescue Building with the capability to become the dispatch center for the county in case the sheriff's office suffers catastrophic damage.
- Purchased some of the radios and pagers needed by fire and rescue services to alert their emergency responders of the need for their services.

The county is nearing the completion of the projects to improve communications and thus resolve any issue of interoperability during future emergencies.

Much of the money that was used to complete the aforementioned projects was made available by the U. S. Department of Homeland Security and the Virginia Department of Emergency Management. Lancaster County has received notice of the 2004 funds that are available for these purposes. The total Lancaster County will receive in 2004 has been determined to be \$56,492. This year, an additional requirement has been placed on the county's use of these funds. Each incorporated town is eligible to receive \$3.15 per capita to use for the listed emergency preparedness purposes. Thus each town in Lancaster County would receive the following:

Irvington (2000 population= 673)	\$2,120
Kilmarnock (2000 population = 1244)	3,919
White Stone (2000 population= 358)	1,128

Your town is entitled to aforementioned amount "unless the town council waives this approach in favor of the county providing services." The grant allows the town council to participate in the county's emergency operations projects.

Inasmuch as the county's plan to upgrade the radio system for the sheriff, fire and rescue is incomplete, I ask that the town council consider waiving its portion of the 2004 Homeland Security Grant funding in favor of Lancaster County's plan of action. This will require a formal motion/resolution of the town council.

Your funds will be used to purchase the pagers each of the local fire departments has informed us are needed to summons their volunteers as well as work with the new radio equipment that has already been installed in Lancaster County.

Please let me know, at your earliest convenience, the decision the town council has made regarding this request. I will be pleased to appear before the next council meeting to explain this project in greater detail.

The Transportation Enhancement Program may fund many improvements including, but not limited to, such items as upgraded sidewalks, historically appropriate street lighting, street furniture, refuse containers, landscaping and plantings, extending proposed bike paths from the Commons to other parts of the town, and improved drainage, curb and gutter systems.

A member of the Village Improvement Association has volunteered to assist in the preparation of the application for project funding if the Mayor and Town Council authorize such an effort. We envision that the improvements will be made and funded in stages over the course of the next several years based upon priorities to be established by the Town Council.

We are requesting that the Mayor and Town Council approve the drafting of an application for Transportation Enhancement Program funds for the consideration of the Mayor and Town Council prior to the November 1, 2004 application deadline for funding after October 1, 2005.

Public Hearing:

Mr. McAfee requested that when approving the budget, the Council remember the Museum with the same appropriation as last year or more than the \$20,000 that was given to the Museum last year. (Evans arrived) The Museum is now open. Mrs. Dianne Jordan stated that the Museum was available for use by the community and she would like to see it become a community center. Mr. Mosher stated that his questions about the financial state of the Museum have been answered by the Museum's Strategic Plan and he haughtily endorses helping the Museum and he recommended giving the Museum \$30,000 this year. (Mr. Pittman arrived.) Mr. Ransone said that it would be contingent on the Town's having the money. Mrs. Pollard stated that she would like to see money go to gas lights and street signs. She did not think that the signs like those in Hills Quarter were appropriate for Irvington and she will continue her research. Mr. Luckham said that signs could be upgraded in selected parts of Town. Mr. Evans would like the Town to consider a part time policeman and asked that it be added as a line item to the budget. The Mayor opened the meeting with a prayer. He welcomed guests and visitors.

Public Hearing:

Mihills Subdivision-York Road: Norman Mosher made a motion to go into a public hearing and Kathleen Pollard seconded the motion. Vote – Yea: Luckham, Mosher, Pollard, and Ransone. Nay: 0. Mr. Fitzpatrick stated that the fees were paid, notices given, and that the Planning Commission had unanimously recommended approving the subdivision based on the condition that the Health Department approves the subdivision. The Zoning Administrator will sign off on the plat after the Health Department has signed off on the plat. The Mihills Subdivision will consist of six (6) plus acres being divided into five (5) parcels. The subdivision meets all requirements except those applying to large subdivisions. The road is private and will remain private. (This is allowed when there are less than 25 parcels. Should the road be taken over by the State, it must meet State requirements.) Mr. Mihills plans to install engineered septic systems. The Mihills said that they would probably tear down the Dunaway house. Norman Mosher made a motion to come out of the public hearing and Kathleen seconded the motion. Vote – Yea: Luckham, Mosher, Pollard, and Ransone. Nay: 0. Gary Luckham made a motion to approve the

subdivision with the condition that the Health Department must approve the subdivision. Norman Mosher seconded the motion. Vote- Yea: Luckham, Mosher, Pollard, and Ransone. Nay: 0.

Conditional Use Permit: The Local - Doug Reed, Trick Dog Shops: Ralph Ransone made a motion to go into a public hearing. Gary Luckham seconded the motion. Vote-Yea: Luckham, Mosher, Pollard, and Ransone. Nay: 0. Mr. Reed is applying for a Conditional Use Permit to operate a coffee shop, serving breakfast and lunch, and will sell alcohol (beer and wine off and on the premises), but will not sell mixed drinks). Mr. Fitzpatrick stated that the notices had been given and there was one written objection from Mrs. Frances Ramzy. This was an after the fact application because Mr. Fitzpatrick neglected to tell him that he could not begin operation until he received his permit. Mr. Reed applied for a permit to operate the coffee shop 7 days a week, from 7:00 A.M. to 5:00 P.M. The Planning Commission amended the application to approve the application for hours 7:00 A.M. to 7:00 P.M. Mr. Reed's business sign attached to the building is about 52 square feet - larger than the 36 square feet allowed for an against the building sign. He has elected to go to the Board of Zoning Appeals to request a variance. Mr. Reed does not anticipate having heavy beer and wine sales. Mr. Phillip Thomas, who lives across the street and is a retired Methodist minister, said that he recognized the prevalence of alcohol, but he thought there should be a limit to beer and wine sales in a small community and expressed disapproval of it. The Mayor expressed concern about alcohol available for sale at 7.00 A.M.

Kathleen Pollard made a motion to come out of public hearing and Ralph Ransone seconded the motion. Vote – Yea: Luckham, Mosher, Pollard, and Ransone. Nay: 0. Mr. Ransone asked Mr. Reed about his serving dinner, and Mr. Reed responded that he was not equipped to serve dinner. He said that there were no lease restrictions regarding his hours. Mr. Ransone mentioned the aspect of drinks being served close to the street. Drinks must be served within an enclosed area. Ralph Ransone made a motion to approve the CUP and Norman Mosher seconded the motion. Vote – Yea: Luckham, Mosher, Pollard, and Ransone. Nay: 0.

Zoning Administrator:

Tavern Road: Mr. Fitzpatrick reported on his meeting with Mr. Staton, Mr. Dennis Scott, and Mr. John O'Shaughnessy. Chesapeake Bank is going to bring its entrance up to VDOT's standards and will pay for the work on the entrance. VDOT will complete the Tavern Road project in October. The Town will pay for materials, to a maximum of \$10,000. VDOT will apply oil to the temporary work that they have done after the Fourth. Mr. Fitzpatrick said that the sidewalk will be removed. Mr. Ransone asked to see the VDOT's plans. The VIA/ICC would like a separate entrance to the Commons, which VDOT has said they can do that, and the Town will be responsible for the cost of the culverts.

<u>Water/Sewage Feasibility Study:</u> Mr. Fitzpatrick reported that the Water/Sewer Committee will meet with JimCornwell, an Attorney, who will work with the Committee, on June 23, 2004.

Emergency Generators: Mr. Fitzpatrick stated that Clive Parker, with whom he had discussed Sydnor's providing emergency generators, has left Sydnor. Mr. Jesse Royal will investigate the possibility of Sydnor's providing generators.

Bike Path: No reported progress.

<u>Boundary Line Adjustment:</u> White Stone and Kilmarnock are considering adjusting their boundary lines. The issue for Irvington to consider if it were to expand its boundaries is how far should they be extended. Mr. Terry read the State Statue and stated the notification procedure. On a map, the Mayor pointed out possible new boundaries. Pros and cons were discussed, such as perhaps loss of small town flavor, need for police protection, being stewards of an increased area and population, and control of types and extent of development. The Mayor appointed a committee of Kathleen Pollard, Norman Mosher, Ralph Ransone, Mat Terry, and Jack Fitzpatrick to consider where the boundary lines should be if Irvington were to adjust its boundaries. Mr. Terry would serve as the attorney. He reminded the Council that the Justice Department would have to approve the boundary adjustment because of the impact on the voting districts.

Mr. Terry suggested that an article be placed in the Record stating that the Town is considering boundary adjustment as a means of addressing water and sewage.

Town Office Interior: Mary Fitzpatrick and Chris Jenkins will work with Kathleen Pollard on the interior of the building after the Fourth.

<u>Flags, Banners, and Christmas Lights:</u> Mr. Fitzpatrick reported that Dominion Power has notified the Town that it must first have permission – and there will be a charge, for placing the flags, banners, and Christmas Lights on its poles. Mr. Terry did not recommend charging them an utility tax as he said that would be passed on to the customer.

The Mayor asked the Flag Committee to consider placing the flags further west on King Carter Drive where the road narrows. Garry Luckham said that the poles are irregularly placed and that trucks and trucks loaded with boats can damage the flags.

<u>Steamboat Era Museum Raffle Permit:</u> Norman Mosher made a motion to approve the raffle permit for the Museum and Garry Luckham seconded the motion. Vote-Yea: Luckham, Mosher, Pollard, and Ransone. Nay: 0.

Tavern Road: Mr. Westbrook (Hope & Glory), Mrs. Peggy Patteson (Hope & Glory), Mr. Staton (VDOT), Mr. Burgess (VDOT), Mr. Harper(VDOT), Mr. Fitzpatrick, and the Mayor met to discuss Tavern Road. VDOT representatives have said that the Bank has to correct its entrance before Tavern Road can be improved to correct the drainage problem. The cost to the Town for materials will remain at \$10,000 or less. Work (hard surfacing) will not be done until October.

Ditch: The case is in the hands of the attorneys.

Susan O'Shaughnessy's Letter of Commendation: The letter has been completed. (Ralph Ransone arrived.)

<u>Sewer System:</u> Mr. Fitzpatrick reported that meetings are being held. Four engineering firms have been interviewed. A final decision has not been made. After a firm is selected, the contract will be negotiated and parameters for the feasibility study will be determined. Not as many grants are available now as have been available in the past. Norman Mosher suggested that JoAnn Davis may be able to help with grant sources. Ralph Ransone said that one of the engineering firms had said that grant money may be able to be obtained for the feasibility study.

Town Election: Mr. Fitzpatrick reported that the candidates for the Council had not wanted a public forum. Their answers to prepared questions were published in the paper.

Sydnor: Mr. Fitzpatrick said that Sydnor was still owned by Philadelphia Suburban, but the name had changed to Aqua Virginia. He is to contact Sydnor about a generator for emergencies and to check on an emergency horn.

The regular and public meeting of the Irvington Town Council was held at the Irvington Town Council at 7:30 P.M.

The Mayor called the meeting to order at 7:30 P.M. and led in prayer. He announced that the Mayor and Council Members had received and read letters pro and con regarding Lighthouse Towing.

Kathleen Pollard made a motion to go into public hearing. Garry Luckham seconded the motion. Vote-Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

Public Hearing:

Lighthouse Towing: Lee Stephens, Attorney for John Dorsey, Duncan Bright, and Bill Prillaman, said that the yellow cards that had been mailed to the Irvington Post Office Boxholders had come from this Committee.

Mr. Stephens continued and said that towing is not a use that is permitted with a conditional use permit in the B-1 district; therefore, it must go through a 30 day study by the Planning Commission and Zoning Administrator, who will make a recommendation whether to make towing a part of the Zoning Ordinance to the Town Council. He cited examples whereby it has been ruled that towing incidental to the primary use of the property cannot be the basis for a non conforming use. He does not considered auto services to include towing. He considers that towing belongs in an industrial zone rather than in the business district. He stated that in maneuvering towed vehicles into the station traffic problems can be created at the Triangle and that in the Comprehensive Plan, it is stated that the Town should explore methods to calm traffic. He stated that the application should not be considered at this date because a site plan was not included with the application. When considering the safety and welfare of its citizens, the application should be evaluated in terms of traffic, car waste, and impact on the environment. There should be a system to contain and haul away hazardous waste, and assurance that the septic system is operational and is certified by the Virginia Department of Health. He summarized that the Comprehensive Plan should be the guide as to the direction the Town is going.

Citizen Comments:

site:

The citizens expressed the following concerns about Lighthouse Towing's being located at this

1. Traffic, congestion, obstruction of visibility from the Post Office.

2. Pollution of the Creek/Selby Nature Trail from hazardous waste (leaking fluids)

- 3. Incompatibility with long range plans of the Comprehensive Plan
- 4. What the children at Chesapeake Academy would see
- 5. Not in keeping with what Irvington is becoming

6. Planning Commission's recommendation should prevail

- 7. Cars might accumulate and/or stay longer than two weeks
- 8. 24 hour operation noise after daytime hours
- 9. Towing's not being part of auto services
- 10. Leaking hydraulic fluid from the lift in the station
- 11. If the Ordinance does not specifically permit towing as a use in this district, then the parcel needs to be rezoned to allow it.
- 12. Including minor repairs in the application is a trick, as the previous owner's station grew from doing minor repairs to doing towing.

Clark Winner asked that the Planning Commission's recommendation be read: The Planning Commission did not consider towing to be compatible with long range plans of the Comprehensive Plan.

Richard Carpenter asked the Zoning Administrator to summarize the number of letters received. For: Mitchell, Gaskins, Bob Barrack, Mrs. Ramzy's daughter, and the Christophers (Johnny Christopherowner of the property). Against: Bright, Dorsey, and Prillaman, Chesapeake Academy, Tides Inn, and the Irvington Planning Commission. Mr. Fitzpatrick said if the neighbors, who lived within 300 feet of the property did not respond to their notices, then it was deemed that they had no objection. Dr. Carpenter said that if towing does not fit, then the application must be denied.

Other citizens did not object to Lighthouse Towing's moving to this location and stated that Mr. and Mrs. Davis should be given an opportunity. One citizen said that the Council can address the fears by defining how the business can operate and placing requirements to prevent pollution. The Zoning Administrator stated that he thought towing came under 6-1-9, it was not necessary to rezone, and he thought towing was an auto service. The Town Attorney agreed that auto services covers an array of services including towing.

Johnny Christopher, owner of the property, stated that the septic system has been checked and it does work as Mr. Henry Whay has inspected the system and it will accept 12 gallons per minute with no backup. Mr. Mike Christopher said there was not case in VA where towing is distinguished as a use other than automotive. He said that Lighthouse Towing is a first class towing service, Mr. and Mrs. Davis do not keep cars very long, and they are community-minded.

In response to the concerns, Mrs. Davis: said their business is emergency service – 24 hour service – go to the scene and go home. Unsightly wrecked cars will be behind the fence, covered, and parked on plastic. They now have four wrecked vehicles. In addressing tourism, she said that there were eleven towing businesses in Williamsburg and one was next to the Visitor's Center. They were not here to benefit the other businesses, but the whole community. By the definition she cited, she did not considered that towing was industrial as they were not making anything. They tried to get rid of cars as quickly as possibly. They have a professional title service to obtain titles to the cars. They will try to keep the premises clean and improve the appearance. She asked to be given a chance.

Ralph Ransone made a motion to come out of public hearing. Garry seconded the motion. Vote - Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

Council Discussion:

Kathleen Pollard was concerned about the bio-waste. She asked how they were going to get rid of the bio-waste. Mr. Davis said that oil would be poured into a bulk oil tank, which would be pumped into a truck and hauled away. The plastic would be rolled, folded, placed into the vehicle, and it would go with the vehicles when they leave the premises. The trucks would be behind the building/ fence.

In response to one comment, Mr. Davis said that he would take a truck home and would respond to a call from there. Mr. Mosher said that the Council needs to know the condition of the property nowwhether the tanks have been removed, the septic works, the drains work, and the lift is not leaking hydraulic fluid. He said that there needs to be a baseline evaluation in case a pollution source is challenged in the future. He is concerned about problems arising from the possible biological waste from wrecked cars in the hot summertime when fatalities have occurred. He said that if the Council approves this CUP, then conditions geared to the community should be imposed. Mr. Mike Christopher said that the tanks were removed two years after gas stopped being sold, soil samples were taken and the reports were sent to the DEQ.

Mr. Evans said the Council needs to have conditions concerning the number of cars, lighting, and hours of operation. He said the concern of the citizens was split down the middle.

Mr. Davis said that he did not understand all the objections and thinks it is wrong to to shoot them down. He said to put in the restrictions and give them a chance. Mr. Mosher noted that it was stated at the Planning Commission Meeting that the Mr. and Mrs. Davis were planning to be here for only 3-4 years before they purchase their own property. Mr. Davis said that they would like to purchase the property if Mr. Johnny Christopher would sell it.

Mr. Luckham said that to deny the application would be to condemn Mr. Christopher's property. He made a motion to approve the CUP with conditions: cars being held no longer than 60 days, no disassembling or salvaging of cars, no leasing of cars, no sale of auto parts, limit of ten cars, hours would be 8-5, contain hazardous material, no wreckers in public view. The motion died for lack of a second.

Mr. Pittman said the Council should look at public opinion. He did not think towing applied to B-1 or was implied in auto service. He said frequent access did not apply. He said most residents are opposed. In the case of Irvington's changing: He said that he had found that one newcomer wanted it and two long-time residents were opposed.

Ralph Ransone said that Irvington has been built on diversity. He is not opposed to business. He said that he would go along with the Town Attorney and the Zoning Administrator as they said the business was permitted, but conditions were needed. He thought other problems could be created by not approving the application.

Norman Mosher said that he did not think the Council was competent to decide technical conditions. The application should be sent back to the Planning Commision to determine the restrictions to govern the business and he made a motion accordingly. No second.

The Mayor said that the matter had been put off for two months. Norman Mosher said that the Council needed to be very thoughtful as the Town would have to live with it.

Garry Luckham made a motion to approve the CUP application and Ralph Ransone seconded the motion.

The conditions are:

1. Individual vehicles should not remain on the premises more than 60 days

- 2. No disassembling or salvaging of any vehicles
- 3. No sale of vehicles, parts from wrecked vehicles, and no leasing of vehicles
- 4. No more than ten cars at one time
- No wreckers in public view. This was amended to permit one wrecker to remain in public view

Bill Evans suggested that the hours of operation would be 8:00 A.M. to 5:00 P.M. Ralph Ransone added that the wrecked vehicles would be covered with a tarp and plastic placed under the wrecked vehicles. The tarp and plastic will be removed with the wrecked vehicles when they are removed from the premises. The zoning administrator will inspect the business during the first few months. Mr. Davis will be allowed one wrecker (the one he is driving) to be visible to the public.

Bill Evans asked for certification. It was noted that the former use of the property was known. Mat Terry said that it would become Level II certification and that was expensive. He said the Council may want to ask for copies of certification. Welding would be done on the inside of the building. Mr. Terry said that revocation of the permit would occur if they violated the conditions. He advised that the Council ask that hazardous materials be contained in plastic or whatever materials are necessary. The Zoning Administrator will routinely visit to ascertain that the conditions are being met. All damaged cars will be stored inside the fence. There was a discussion between Mike Christopher and Norm Mosher whether or not the lift leaked hydraulic fluid. Mr. Mosher said because of the chattering of the lift, that air was leaking into the lift. Mr. Christopher said that it did not leak. He said that DEQ has received a report for everything that has been done at the site.

Vote – Yea: Evans, Luckham, and Ransone. Nay: Mosher, Pittman, and Pollard. The Mayor said that the Town Attorney said that it was legal and he voted Yea. The C.U.P. for the Lighthouse Towing was approved with conditions.

Mr. Ransone made a motion to go into public hearing and Garry Luckham seconded the motion.

CUP Application: Swimming Pool - Mr. and Mrs. William Howard at 84 Rowe Point: Mr.

Fitzpatrick said that the notices have been published, notices have been given to the neighbors, and the fees have been paid. There were no objections by the neighbors, and the pool will be located according to the Bay Act requirements. Garry Luckham made a motion to come out of public hearing and Kathleen seconded the motion. Vote – Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0. Robert Pittman made a motion to approve the CUP and Garry Luckham seconded the motion. Vote – Yea: Evans, Luckham, Mosher, Nay: 0.

Motion was made and seconded to go into a public hearing.

CUP Application: Home Occupation-Barbershop: Ms. Leah Makris at 128 Steamboat Road:

Mr. Fitzpatrick stated that this was an acceptable home occupation. Mrs. Petty, a next door neighbor, had objected. There were three neighbors approving the home occupation. Mr. Fitzpatrick stated that the other neighbors, who have not replied are considered to have approved the CUP. Mrs. Petty citing existing traffic problems on Steamboat Road because of activities at Chesapeake Academy, said that she has problems going in and out of her driveway when there are functions at the Academy and this use of the property would add to the traffic problem. She did not think that the driveway would accommodate two cars side by side, but Mrs. Makris said that the driveway would support two cars side by side.. Mr. Ahlborn said that he has asked parents to park only on the Academy side of Steamboat Road, on the Lane, and on the soccer field when it is dry. Robert Pittman made a motion to come out of public hearing. Kathleen Pollard seconded the motion. Vote - Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0. Mrs. Markris said that she planned to work 4 days a week 9-4. She wants the public to dictate the hours. Her barbershop will be geared to men; however, she may do salon cuts for women and may like to have a ladies' evening. She will work by appointment rather than walk-in. Signage will be according to ordinance requirements. Garry Luckham made a motion to approve the CUP and Kathleen Pollard seconded the motion. Mr. Terry read the Art. 2, Section 54, and Article 2, Section 95 on signs. Sign size is limited to two square feet. Vote - Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0. The Zoning Administrator is to contact VDOT for additional "No Parking" signs for the Pettey side of Steamboat Road.

VIA Calendar:

Mr. David Raffetto presented the ICC/VIA Calendar. Mr. Ransone made a motion to approve the calendar and Kathleen Pollard seconded the motion. Vote – Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

Minutes and Treasurer's Report:

Kathleen Pollard made a motion to approve the minutes and treasurer's report. Garry Luckham seconded the motion. Vote – Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

New Business:

<u>Renewal of Chamber of Commerce Membership</u>: Bill Evans made a motion to renew the Chamber of Commerce membership and Garry Luckham seconded the motion. Vote – Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

<u>Grasscutting:</u> Ralph Ransone made a motion to accept the bid of Kilmarnock Enterprises to cut the Town grass for three years for \$1200 per season. Kathleen Pollard seconded the motion. Vote – Yea: Evans, Luckham, Mosher, Pittman, Pollard, and Ransone. Nay: 0.

Announcements:

The Mayor announced the dates for the required automobile tag sale.

Mr. Ransone said that the Town Welcome Signs were in a safe place and would be put up when the weather was better.

Adjournment:

The meeting was adjourned.

Gentle people:

As I will be away with the class of 2004 in Florida on Tuesday February 3, please allow this letter to be my "voice" for Chesapeake Academy. Specifically, I restate my objection regarding the proposal to allow a towing operation on property zoned B-1, especially so near the school. I understand that the petitioner has amended the original conditional use permit to "fit" the rule which was previously categorically denied by this commission last month.

My objection is based in three parts: 1) the visual disturbance of young children seeing wrecked cars coming into and leaving Irvington, and 2) the type of heavy vehicular traffic anticipated during the school day and after school programs, further 3) such a permitted use goes against the Comprehensive Town Planning Document.

I am particularly concerned about the "life" of destroyed vehicles, the daily comings and goings of junk with an average visit of 3 weeks, and the children's expectation of daily traffic. "What's going on over there?", "Did you see that one? It was totally destroyed!", resonate in my ears as potential conversation pieces as children grow up under this new challenge. A challenge that is totally avoidable now.

I advise against such a 24 hour business being established in Irvington, in the school zone, in the historic district. It sends the wrong message to our children, that we don't care what they see. By extension, the economics of no more than 26 cars at one time on the lot with several large wreckers for an average visit of 3 weeks means at least one car in and one car out every day. In part the reasoning given to move the business from a home location was that people came by at all kinds of odd hours. This is not traffic we want in the center of Irvington.

As Head of School I represent 116 families who enroll 155 children ages 3-14. Please do not allow a wrecker service to occupy the center of town. In addition, I ask you to please insist that the septic system, any ground contamination from oil and underground tanks, and the practice of storm drain waste disposal be investigated and ceased immediately. Having now been apprised that such has been the practice I am appalled that members of the commission have known and not insisted that immediate corrective action be taken.

CHESAPEAKE ACADEMY

AN ESSENTIAL EDUCATION

At the Academy, we have been told that to license an upgraded lunch program we have to install a new septic system. The existing one is "too old" and will not be permitted for the new use of a licensed kitchen. However, we have two fully permitted septic fields and are intentionally over engineered to meet the needs of the community when visitors come to campus. With this level of scrutiny on an already permitted system that drains into the same head waters of Sam's Cove, I ask that equal scrutiny come to bear on the property in question. From what I heard at the last meeting it is apparent that the town has been aware of potential ground contamination from this location with no action.

Leaching and storm water runoff into Sam's Cove comes in contact with school children on the Henry G. Selby Nature Trail. Certainly the town wants to protect children from environmental pollution.

I ask you to please address the following in the Planning Document and justify how permitting such use of the existing facility will:

Calm the flow and speed of traffic to protect citizen safety (Infrastructure Goal 1 pg 54)

Develop methods to prevent ground water pollution to protect citizen safety (Natural Resources Goal 1 pg55) – are the underground tanks up to code?

Improve storm water drainage (Natural Resources Goal 2 pg 56) – stop the practice of dumping waste in the storm drain

Be harmonious with surrounding residences and businesses (Section 3 Business - Existing B-1 zone pg 61)

As part of the Chesapeake Academy Rowe Campus is in the historic district, I suggest to you that a towing service is not in keeping with the spirit of the town, anymore than is fencing in the Academy to keep out stray dogs to protect the children from harm. We live in community and expect our planners, elected officials, and neighbors to watch out for the collective best interests of the town both now and into the future.

Thank you for your kind attention in support of our children and their future.

> CUP for 4525 Irvington Road Towing Service or Auto (minor repair) & Towing service

As an adjacent property and business owner, I ask that you please consider the following as you make your voting decision in the best interests of the Town and the residents of Irvington.

- The property in question is zoned B-1 and the Statement of Intent for Article 6 clearly indicates this property is *"intended for the conduct of general business to which the public requires direct and frequent access."* (italics are mine)
 - A towing (or the revised CUP submission)) does not in any manner meet this requirement. The applicant in their advertising on radio, yellow pages or calling cards does not, in any instance, indicate an address for their business—only a phone number. Had access by the public been important to the success of the business, the street address would be prominently displayed or mentioned.
 - It is clear that public access is not a requirement-only 24 hour phone availability
 - Towing is more appropriate under M-1
 - Frequent public access (among others) is what differentiates B-1 from M-1
- The Planning Commission originally voted 4-0-1 against permitting the approval of the CUP for a towing service
- The fact that the visual appearance of the previous business was tolerated and nothing was done when tow trucks and roll backs were added is no reason the town and residents should continue to tolerate businesses that do not enhance the appearance and safety of the residents and school children in Irvington.
- After the applicant's statements at both the Planning and Town Council meetings, the resubmission of an alternative CUP application clearly indicate the applicant themselves agree that a towing service is not allowed under B-1.
 - o The applicant stated "if someone stopped at their business and required repairs they would gladly tow the car to a garage that repairs vehicles" .. (paraphrased)
 - Adding "minor auto repair" to a new CUP application seems to be an after thought to obtain approval and, in a way, indicates that other businesses will be added as time goes by.
- Those of us who have selected Irvington for the base of our businesses did so in the belief in the future of Irvington and the desire to improve the quality of businesses that are attracted to the Historic District. Those that care have invested to improve the visual aspects.

To facilitate public understanding of this ordinance and for the better administration thereof the regulations limiting the use, buildings and arrangement of buildings are for the most part set forth in the following schedule for each of the districts established by Section 500 of this ordinance. Such schedule is hereby adopted and declared to be a part of this ordinance hereinafter referred to as the schedule, and may be amended in the same manner as any other part of this ordinance.

Wherever in such schedule there appear the words "same as in (Symbol of district) above:" such words shall be construed to include the specific limitations set forth in the same column for the district thus referred to. Otherwise, all limitations as to uses permitted, permissible height, required yard, and minimum sizes thereof and other requirements shall be those set forth in such schedule.

The following applies to all Zoning Districts:

- A. Planned development projects are permitted in any district.
- B. All area regulations are subject to the provisions of Section 503.4 where public sewer system is not accessible.
- C. Minimum Front Yard Dimension is from the street right-of-way line.
- D. Maximum Building Height may be increased one foot for each additional foot that each yard exceeds the minimum, except for signs.

701 AGRICULTURAL (A-1)

701.1 Intent

This zone is established to preserve the rural character of the agricultural service area by promoting agriculture and related uses, and by discouraging all forms of urban development except for a limited amount of conditional uses.

701.2 Principal Uses

A. Agriculture, including greenhouses and nurseries.

- B. Riding stables, and fishing lakes.
- C. Public parks, playgrounds, public or privately owned golf courses, forests and conservation areas.
- D. Single family detached dwellings.

718.4 Conditional Uses (Amended September 1995)

- A. Recreational activities such as: billiards or pool halls: fitness, exercise and sports centers; skating rinks; theaters; and bowling alleys.

 - 3. There shall be no disassembly or salvaging of any of the vehicles.
 - 4. There shall be no sale of vehicles and/or automotive parts.
 - 5. Hazardous materials shall be contained in one area.
- E. Kennels and pet grooming. (Amended June 1998)
- F. Restaurants with no drive through facilities.
- 718.5 Prohibited Uses

All uses other than those listed as principal, accessory, or conditional uses or substantially similar to principal, accessory, or conditional uses shall be prohibited.

the reproduction of a steamship bow floating in the water. There will be dioramas depicting areas of a steamboat.

John Dorsey said that the Museum would be a learning center and there will be programs for each school grade level.

Jimmie Lee Crockett has been in contact with Mariners' Museum and he said there are plans to restore the Pilot House.

Duncan Bright said that he was impressed with the Museum's plans and that he hoped that the Commons would be equally impressive.

Garry Luckham made a motion to approve the appropriation of \$20,000 to the Museum that was allocated in the budget and discussed at previous meetings. Kathleen seconded the motion. Norman Mosher made an amendment that all Irvington citizens and Irvington children be admitted free because of the bed tax and said that it offends him that Irvington residents have to pay. Mr. Evans seconded the motion. Vote on admendment: Yea: Evans, Luckham, and Mosher. Nay: Pollard and Ransone. Mr. Mosher asked how much money had been raised toward the \$700,000 that he had heard was needed. Of that amount, \$400,000 was needed for exhibits. The treasurer of the Museum was not present, and no one could answer the question. Mr. Mosher moved to postpone indefinitely authorizing the appropriation to the Museum and the public hearing regarding appropriating the allocation until the Council receives definite answers regarding how much the Museum has received. There was no second. Mrs. Pollard said that the Council could give some help this year and then reconsider next year whether to make a donation. She noted that the Museum is in the upstart and that they need seed money. The Mayor said that he was concerned because this has been discussed previously. Mr. Mosher asked if the Museum Board had a clear picture of who is responsible for the fundraising. The Mayor said that a director had been hired, Mr. Westbrook will chair the Foundation, and he named the members of the Foundation. Mr. Mosher said that citizens of Irvington are calling him to say that they do not believe this is the highest priority. He said that he had been unable to get specific answers as to the amount of money that has been raised. Mr. Dorsey stated that he has been a part of the Museum for 1.5 years and in that time a strategic plan has been threefourths completed, the Foundation has been created, knowledge has been acquired about fundraising, and a job description has been completed for the Museum director. The pledges in the last couple months have been over \$100,000. He said it was decided that the director should be hired before beginning the fundraising. Mr. Dorsey asked the council to consider the museum as a child and to give it chance to grow up and then the council would be proud of the Museum. Mr. Dorsey said that he would discuss money with Mr. Mosher next week. Mr. Evans said that he appreciated the Museum's representatives discussing the Museum with the Council. Vote on appropriation: Evans, Luckham, Pollard, and Ransone. Nay: Mosher.

Water/Sewer:

The Mayor stated that Mr. Fitzpatrick is attending the water/sewer meetings with Rappahannock-Westminster Canterbury and White Stone. The three areas involved would like to obtain separate grants.

Architectural Review Board:

Mr. Fitzpatrick is going to work with Mr. Terry on the ramifications of an architectural review board. A list of restrictions would be needed and the applicable area needs to be determined.

Commons Area:

The committee has provided a plan or procedure for engaging the community to provide citizens' input before a plan is developed.

Public Hearing:

Kathleen Pollard made a motion to go into a public hearing. Norman Mosher seconded the motion. Vote: Evans, Luckham, Mosher, Pollard, and Ransone. Nay: 0.

Mr. and Mrs. Davis: CUP: Operate a towing service at 4525 Irvington Road. Mr. and Mrs. Davis are applying for a C.U.P. to operate a towing service in the location formerly occupied by Bernard Brown, who operated a service station which included no gasoline sales, but did include a towing service. Mr. and Mrs. Davis do not plan to have a service station, but want only a towing service. Mr. Brown applied for a permit to repair engines. The Planning Commission voted not to recommend approval of the CUP. They did not think that towing was a specified use in the Ordinance. Mr. Bright said that the former's going from a service station and ending as a towing service is the same fear that he has about what will develop from this towing service. He said that as a resident of Irvington, it was not appropriate business as a welcome to the historic district. He said that Irvington was becoming more gentrified. Mike Christopher, who said that his father owned the property, said that an auto service station had been there for 50 to 80 years and that the Davises were well respected in the business community. He said that the intensiveness of the property would decrease as they would work on only their vehicles and that it would not be a retail business. Mr. Davis said that it would not be a chop shop. They will put in plants in the front and try to improve the appearance. David Raffetto said the problem was in the definition. Bill Prillaman said that if the use is not specifically allowed, then it would require a zoning change to be allowed. Garry Luckham made a motion to come out of public hearing. Kathleen Pollard seconded the motion. Vote: Evans, Luckham, Mosher, Pollard, and Ransone. Nay: 0.

Mr. Terry said that the section/article in the Ordinance under consideration was 6-1-9. Auto Service would include towing service and this service was provided by the former tenant, thus creating a He said that the Council could approve or disapprove the application and could impose precedent. conditions. Mr. Evans said that time was needed to talk with the public, but Mr. Terry said that the public hearing was the opportunity for the public to be heard, the public was present at the hearing, and it was a representative democracy. Mr. Mosher said that he has heard that the septic system needed overhauling. Mrs. Pollard questioned how many cars could be parked behind the fence and the length of time the cars would be held. Cars are held until the insurance adjuster can view them - up to three weeks. After 15 days, they can obtain the title to try to sell the cars. Mr. Ransone said that he saw a lot of uses that he would prefer not to have and would rather have Davis. He said that they could put towing as one of the uses and could put it in one of the reserved slots in the list of uses. Mr. Luckham said that they could impose conditions. Mr. Evans made a motion to table the decision for thirty days to hear from the public. Mr. Mosher said that he would amend the motion that there be a requirement that the County certify the septic system. Remedying the septic system problem could be a condition imposed. Mr. Evans made a motion to table making a decision to the next meeting and look at situations such as the septic system. Norm Mosher seconded the motion. Garry Luckham said that this was no worse than what Mr. Brown had, but he was concerned with the septic system. Vote to table until February 12, 2004 (next meeting). Yea: Evans, Mosher, and Pollard. Nay: Luckham and Ransone. Mr. Ransone added that Mr. Davis would be towing cars to other service stations.

Tavern Road: VDOT - Mr. Staton:

The Mayor explained the problem of standing water on the shoulders of Tavern Road, especially on the Commons side. Mr. Staton said the problem was created by the drainage from King Carter to Chesapeake Drive. He said that the entrance to Chesapeake Bank was non conforming. He said there was a thirty foot right of way with an 18 foot paved road. He said that it was difficult to maintain the road with parking and with a ditch to the drain area. He said that to install curb and gutter would be the ideal solution, but that would be costly. The town would have to go before the Lancaster Board of Supervisors, have the project accepted and placed on the 6 year priority plan of projects, and then compete with all the other Lancaster County projects. He said that there were uncompleted projects from when he came here 26 years ago. He said that on Tavern Road, there is less than 1 foot of fall for 500 feet. He said there could be a cooperative effort to improve the situation. In essence, the Town would pay for the materials and VDOT would provide engineering and grading. He estimates that it would take 200 tons of asphalt @ \$30.00 a ton and 150 tons of stone @ \$15.00 a ton. He "rounds up" and estimates that the cost would be \$10,000 or less. The Town would be charged for only the cost of the materials. He said that to make their grading effective, it was essential that the Bank put in a new entrance, according to commercial standards. He told Mr. Westbrook that the water would not collect if the Bank would put in the new entrance. He said that this was also the time for the Town to consider an entrance to the Commons. VDOT would put down stone and pave the sides with a shallow swale 1" to 2" deep, thus stabilizing the swale. The pavement would go up to the fence of Hope & Glory. He said that the Town would give VDOT a resolution stating that it was fine with him for VDOT to do the job. Mr. Ransone made a motion to approve a resolution to allow VDOT to improve Route 715 (Tavern Road) with no more cost than \$10,000 for materials and subject to Chesapeake Bank's improving their entrance. Mr. Evans seconded the motion. Mr. Mosher said that it was important Chesapeake Bank recognize that their bank entrance was not up to standards. Mr. Staton said that they can do the project next summer or as soon as possible and it would take a week.

Minutes:

Norman Mosher made a motion to approve the minutes of the December meeting. Bill Evans seconded the motion. Vote: Evans, Luckham, Mosher, Pollard, and Ransone. Nay: 0.

Norman Mosher made a motion to approve the treasurer's report and Bill Evans seconded the motion. Vote: Evans, Luckham, Mosher, Pollard, and Ransone. Nay: 0.

Christmas Decorations:

It was decided that the 11th was the more convenient Sunday to take the lights off the Christmas Tree. The Clerk will contact One Stop.

The Ditch:

Mr. Terry told the Council that they had been served papers unnecessarily. Mr. Nunnally has refiled his complaint and it has been forwarded to the insurance company.

Adjournment:

The Mayor adjourned the meeting.
