INITIATING AND REFERRING A ZONING ORDINANCE AMENDMENT  
Proposed Amendment to Update Language Related to the Zoning Permit Fee**

**WHEREAS**, Town Council has considered a proposed amendment to the zoning ordinance of the Town of Irvington, Virginia (the “Amendment”); and

**WHEREAS**, the proposed Amendment is attached hereto and described as: removing language in the code describing a static Zoning Permit fee and instead referring to the Council’s adopted fee rate schedule; and

**WHEREAS**, the Amendment is proposed to serve the health, safety, welfare and good zoning practices of the Town and its citizens; and

**WHEREAS**, the Town Council wishes to initiate and refer the Amendment to the Town Planning Commission for its consideration, edits thereto and recommendation thereof.

**Current Language:** Each application for a zoning permit shall be accompanied by a check made payable to the town treasurer, in the amount of \$35.00; provided, however, that as to development within the Chesapeake Bay Preservation Area Overlay District established pursuant to §§ [154.145](#) through [154.158](#), each application will comply with the requirements of the plan of development process set forth in [§ 154.155](#).

**Proposed Revision:** Each application for a zoning permit shall be accompanied by a payment for the amount designated in the most recent fee schedule adopted by Town Council; provided, however, that as to development within the Chesapeake Bay Preservation Area Overlay District established pursuant to §§ [154.145](#) through [154.158](#), each application will comply with the requirements of the plan of development process set forth in [§ 154.155](#).
