RESOLUTION NO. 2026-14

**A RESOLUTION AUTHORIZING THE PURCHASE OF AUTOMATED EXTERNAL
DEFIBRILLATORS (AEDs) FOR PUBLIC USE AND
APPROPRIATING FUNDS FROM THE FY 2025–2026 BUDGET**

WHEREAS, the Town Council recognizes the importance of providing timely emergency medical assistance in the event of cardiac emergencies occurring on public property and at public gatherings; and

WHEREAS, Automated External Defibrillators (AEDs) are proven lifesaving devices that can significantly improve outcomes during sudden cardiac arrest events; and

WHEREAS, the Town desires to purchase and install three (3) Automated External Defibrillators at strategic locations accessible to residents, visitors, and Town officials; and

WHEREAS, the estimated cost of each AED is approximately Three Thousand Dollars (\$3,000), for a total estimated expenditure of Nine Thousand Dollars (\$9,000); and

WHEREAS, sufficient unspent funds are available within the Town's Fiscal Year 2025–2026 Budget under the Office Expenses and Town Maintenance budget line items;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Irvington, Virginia, that:

1. The purchase of three (3) Automated External Defibrillators (AEDs) at an estimated cost of \$3,000 each, for a total estimated cost not to exceed \$9,000, is hereby approved.
2. The AEDs shall be installed and maintained at the following locations:
 - The meeting hall of Irvington Baptist Church, where Town Council meetings are regularly conducted;
 - The tennis courts located on the Town Commons; and
 - The Town Office.
3. The Town Administrator, Town Clerk, and Treasurer are authorized to take all necessary actions to procure the AEDs and arrange for their installation and maintenance.
4. Funding for this purchase shall be appropriated from unspent funds within the FY 2025–2026 Budget, specifically from the Office Expenses and Town Maintenance budget line items, in an amount not to exceed \$9,000.
5. This Resolution shall take effect immediately upon its adoption.
