RESOLUTION NO. 2026-21

A RESOLUTION TO APPROPRIATE AND AUTHORIZE A CHARITABLE CONTRIBUTION TO THE
AMERICAN JUNIOR GOLF ASSOCIATION (AJGA) FROM THE COMMUNITY SUPPORT AND
TOURISM BUDGET

WHEREAS, the Town of Irvington recognizes the value of community events and tourism-related activities that promote the Town, attract visitors, and contribute positively to the local economy; and

WHEREAS, the American Junior Golf Association (AJGA) is hosting a nationally recognized junior golf tournament at Indian Creek Yacht and Country Club, an event that brings visitors, participants, and economic activity to the Northern Neck region; and

WHEREAS, the Irvington Town Council has determined that supporting this event serves a valid public purpose by promoting tourism, enhancing community visibility, and supporting economic development opportunities within the Town and surrounding region; and

WHEREAS, the Irvington Town Council has expressed its intent to provide a sponsorship contribution in the amount of Two Thousand Five Hundred Dollars (\$2,500.00) to the American Junior Golf Association in support of the tournament; and

WHEREAS, funds are available in the Town of Irvington Fiscal Year 2026-2027 Community Support and Tourism budget for this purpose;

NOW, THEREFORE, BE IT RESOLVED by the Town Council of the Town of Irvington, Virginia, as follows:

1. **Appropriation and Authorization.** The Town Council hereby appropriates and authorizes the expenditure of Two Thousand Five Hundred Dollars (\$2,500.00) from the Fiscal Year 2026-2027 Community Support and Tourism budget for a sponsorship contribution to the American Junior Golf Association (a 501c3 public charity recognized by the IRS (EIN: 58-1433914)) in support of the tournament hosted at Indian Creek Yacht and Country Club.
2. **Public Purpose.** The Town Council finds that this contribution serves a public purpose by supporting tourism, promoting economic activity, and enhancing awareness of the Town of Irvington and the Northern Neck region.
3. **Payment Authorization.** The Town Clerk and Town Treasurer are hereby authorized and directed to take all actions necessary to process and issue payment of the authorized contribution consistent with this Resolution.

4. **Effective Date.** This Resolution shall become effective immediately upon adoption.
